The report aims to track investment patterns as they prevail in accordance to the trading activities associated with the various nationality groups active in ASE.

Latest Trends:

ASE Trading

Jordanian investors

- Bought ASE shares valued at JD 93.17 million, and sold JD 70.37 million.
- Resulting in a positive net investment of JD 22.80 million. (Compared to a positive net investment of JD 4.01 million for the previous month, January 2024).

Arab Investors

- Bought shares amounting to JD 8.30 million, and sold JD 10.34 million of ASE shares.
- Resulting in a negative net investment of JD 2.04 million. (Compared to a negative net investment of JD 2.31 million for the previous month, January 2024).

International investors

- Bought shares worth JD 0.56 million, and sold JD 21.32 million of ASE shares.
- Resulting in a negative net investment of JD 20.76 million. (Compared to a negative net investment of JD 1.70 million for the previous month, January 2024).

After examining the number of transactions executed during February 2024, it was found that Jordanian investors were the most active as they have executed 93.67% of the buy-side transactions compared to 92.21% on the sell-side, followed by Palestinian investors with a share of 4.16% of the buy-side and 3.41% of the sell-side, and Lebanese investors accounted for 0.04% of the buy-side and 0.96% of the sell-side.

ASE Ownership

Jordanian investors hold 55.91% of ASE's total market cap, while Arab investors hold 28.47% of ASE's total market cap, leaving International investors with a share of 15.62%.

With reference to the top ASE nationalities according to ownership, the Saudi Arabian ownership in ASE ranked second after Jordanians with total ownership of 5.60% of ASE market cap, while Kuwaiti came in the third rank with an ownership of 4.98% of ASE market cap.

Top ASE Nationalities' Ownership—Market Cap. (Value and Percentage):




